Our Nations's 2010 UPR on the United States of America was recognized and mentioned by 2 Academic Scholars: Molefe Asante & Clyde Ledbetter Jr. in their book: Contemporary Critical Thought in Africology and Africana Studies.

### Submission on The UNITED STATES OF AMERICA Since UN UPR on November 5 2010

- **4.** The United States of America under then U.S. President Barack Hussein Obama, did finally endorse the UNDRIP (albeit reluctantly); however, when cited and used in the courts as counseled by the International Indian Treaty Council (IITC <a href="https://www.iitc.org/">https://www.iitc.org/</a>) the U.S. Courts and associated Courts still breach the UNDRIP and the International laws that are associated and related to the UNDRIP.
- **5.** The United States of America to teach the unbiased education and truthful knowledge of the origins of the Native Americans / Indians in the Americas. The United States of America has extreme difficulty in accepting the fact that the original peoples of the Americas (The Olmecs) were dark-skinned with curly to wavy hair, despite the fact Scholars of the Americas were fully aware of this fact:

To evince this result in a single but striking point, doubted to this day by superficial inquirers, it is sufficient to mention that there were in America, before Columbus came, nations and tribes of the following complexions: coppered, tawny, olive, dusky, white or pale yellow, dark brown, and black; (but none red unless painted.) and that all these complexions are also found in Asia, in Polynesia, and in Africa. The native American Negroes or black Indians, have been seen in Brazil, Guyana, Caraccas, Popavan, Choco, North California, &c. Some of them, such as the Aroras or Caroras of Cumana, were black, but with fine features and long hair, like the Jolofs and Gallas of Africa. Others in New California, latitude 32, called *Esteros*, are like the *Hottentots*, *Numuquas*, *Tambukis*, and many other Nigritian tribes, not black, but dark brown, yet complete Negroes, with large thick lips, broad flat noses, and very ugly, with hair crisped or curly. The Negro features belong to the form of the head rather than the colour, since [there] are in Africa, Asia, and Polynesia, black, brown, yellow, olive, coppery, (and even white) Negroes. - **6.** The United States of America needs to adopt, assimilate, incorporate and implement the UNDRIP Declaration domestically and to legislate domestically that the judiciary and all branches of government are legally made aware of the legal responsibility of obedience not only to the United Nations Declaration on the Rights of Indigenous Peoples, but also the United Nations Charter and International Laws, Treaties and conventions that it has signed and agreed to within and without their domestic courts.
- **7.** The United States of America to Immediately incorporate domestically its legal obligations to honor and protect tribal Sovereignty as defined by Presidential Proclamation 7500 and Presidential Executive Order which is in accord with Articles 2,3,4 of the United Nations Declaration on the Rights of Indigenous Peoples.
- **8.** The United States of America has a factual, scientific and genetic obligation to teach the unbiased knowledge and truthful knowledge of the origins of the Native Americans / Indians in the Americas who are and were what would be today known as: "African-American," "Black," "Colored," "Negro," etc.

- **9.** The Problem that Indigenous People, People of African Descent (MISNOMER: African-Americans, Black, Negro, Colored), have is that BLACK HAS NO STANDING AT LAW. (So Tom Joyner interviews President Barack Obama on his 'Tom Joyner Morning Show' and greets him by saying "It's our first 'BLACK' president of the United States"...President Obama replies 'Tom I don't look at myself as the first 'BLACK' president because the word 'BLACK' has no standing at law.
- 10. The United States OMB FORM SF-181 Form (<a href="https://www.opm.gov/forms/pdf">https://www.opm.gov/forms/pdf</a> fill/sf181.pdf</a> ) specifically states that Black/African-American "is a person belonging to any of the "Black Racial Groups of Africa". There are NO "Black Racial Groups" of Africa and can be proven by anyone who is from Africa as they refer to themselves from a: <a href="https://www.opm.gov/forms/pdf">Tribe, Clan or a Village</a>; Furthermore, People from Africa will tell you they do NOT call/refer to themselves as "Black" in their language. The United States OMB FORM SF-181 Form(<a href="https://www.opm.gov/forms/pdf">https://www.opm.gov/forms/pdf</a> fill/sf181.pdf</a> ) states that "White" is "any person belonging to the Original Peoples of: Europe, the Middle East and North Africa." This would mean that Black/African-American should be calling themselves White and NOT "Black."

This would mean that Blacks/African-Americans should be calling themselves White and NOT "Black." This explains the Injustice, discrimination, atrocities, violations, genocide apartheid and rape committed against Peoples of African Descent (MISNOMER: Black/African-American).
- 21. Failure by the United States of America: to acknowledge, reveal, correct, fix, compensate and restitute this International Human Rights, Indigenous Rights and Universal Rights violations of the fact: Indigenous Peoples, "African-Americans" are commercially in fact White means that the United States of America is fully cognizant that it is complicit in: Genocide, Apartheid, Rape, Forced Assimilation, Forced Displaced, Crimes against Indigenous Peoples, Crimes against Humanity, Fratricide, infanticide, Murder, Conspiracy, Collusion and War Crimes against Peoples of African Descent All over the world and have no intention on fixing and healing the damaged caused, now or in the Future. Any proposed Declaration for peoples of African Descent to

be drafted by The United Nations, the OHCHR and UN WGEPAD must fully reveal the exact definitions of race to Peoples of African Descent

#### **Current Recommendations**

- 22. The United States of America should create a Domestic Full Disclosure Legislation (which would also be in accord with the United Nations International Decade for Peoples of African Descents Programme of Activities: <a href="https://www.un.org/en/events/africandescentdecade/pdf/A.RES.69.16\_IDPAD.pdf">https://www.un.org/en/events/africandescentdecade/pdf/A.RES.69.16\_IDPAD.pdf</a>) for Indigenous People or refer People of African Descent (primarily African-Americans/American Blacks) to the SF-181 Form that will assist them in changing their racial status from "Black" To White. The United States of America should include this as part of the recommendations to implement Human Rights in accord with the UPR also following the programme of activities which they are mandated to honor in accord with the UN International Decade for People of African Descent. United States of America should openly promote the solution to people of African Descent now to change the racial status word "Black," "Black/African-American," "African" (People of African Descent) from "Black" to White and Native American / American Indian or those not born in the west to White.
